1. Name of Education Society: - Milind Shikshan Sanstha, Brahamapuri, at Brahamapuri, Tahsil, Brahamapuri, Distt, Chandrapur (Maharashtra)

3. **Board of Directors :-**

- A. The Board of Directors will give guidance for proper functioning of the educational institute, hostels including mentoring all the students.
- B. The member of Board of Director should not be less than 7 and not more than 15 at any point of time.
- C. The tenure of the permanent as well as temporary Members is considered to be permanent in nature for all member of Board of Director. If the any member was not paid contribution within the time limit or acting in contrast to the bye laws/benefit of the society, than such members position will be

vacated after passing the resolution by majority in Annual general meeting of permanent and temporary members.

Except permanent member, the other members who wants to participate in the work of Society, such members can be selected by majority of Board of Directors.

- D. The Board of Director should fill the vacancy if case of death of any member or becoming lunatic, person of unsound mind etc.

### **Designations:**

1. **President: -**
  - A. The President of Director body from permanent and newly elected member.
  - B. The rotation of the president's post in every 3 years term.
  - C. The president shall vacant his post if any member of Director's body move a resolution against him and resolution is passed in the meeting of directors.
  - D. The Board of Directors can pass the resolution for extension of term of president if the act of president is satisfactory and also beneficial to the society.
2. **Vice-President:-**
  - A. In absence of president, he shall act as president.
  - B. The vice president selection shall be from permanent and newly created member of Directors body.
  - C. The post of vice president is transferred after 3 years.
  - D. The Directors body can pass resolution about extension of limit of vice president, if the act of vice president is satisfactorily and also beneficial to the Society.
  - E. The vice president acting all right of president in his absence.
  - F. The Vice President shall vacant his post if any member of Director's body move a resolution against him and resolution is passed in the meeting of directors
3. **Secretary:-**
  - A. The Secretary of Director body is selected from the permanent and newly elected member of Director body.

- B. Secretary is the important person of Society (pravartak). All right has been given to Secretary.
- C. The Director body can pass the resolution about extension of limit of Secretary, if the act of Secretary is satisfactorily and also beneficial to the Secretary.
- D. In financial transaction, the position of Secretary as permanent.
- E. No any amount has been withdrawn from Educational Society without signature of Secretary as well as joint Secretary.
- F. In every ending of the financial year, the Secretary of Director body placed the financial transaction at the time of meeting and also placed balance sheet.
- G. To do postal transaction with Government and connected officer.
- H. To absolve Society or to continue all these eight given to the Secretary.
- I. There is no necessity of meeting/resolution for dissolution the Society to Secretary.

4. **Joint Secretary:-**

- A. The office of joint Secretary is temporarily in the office of Secretary.
- B. Joint Secretary can help to Secretary.
- C. The joint Secretary is changed in every 3 years.
- D. The Secretary shall vacant his post, if any member of Director body placed before meeting the opposite to Secretary and this meeting passed the resolution by majority.

5. **Meetings: - 1. Annual General Meeting**

- A. The president/Secretary can call the annual general meeting of Secretary body of Education Society.
- B. In the annual general meeting, the discussion of financial transaction and discussion of next year transaction about approximate statement.
- C. Any member or the with the permission of the president placed question about Society transaction in annual general meeting.
- D. The result passed by majority after discussing the question.

2. **General Meeting:-**

- A. General meeting called in between 3 months.
- B. Time, date, place, subject must be noted in notice board about meeting.
- C. Koram -2 / 3 member must be present.
- D. 7 days before notice must be given to all members.
- E. There is no necessity of koram for adjustment meting.
- F. Each member having one vote.
- G. No response given of any members opinion in the meeting in his absence.
- H. The president use his vote power, if the same vote given the meeting.
- I. Adjustment meeting will be called after one hour.

6. **Financial year: -** 1<sup>st</sup> April to 31<sup>st</sup> March is financial year of Educational Society.

7. **Economical Management of Library:-**


- A. After registration of Education body, every member of Educational body has given contribution of Rs.100/- per year accordingly till 5 year.
- B. Nithin 7 days, the said amount be given to the Secretary/president of library for proper execution.
- B. Government agent.

8. **Amendment in constitution: -** According to Para 12, 14 of Society registration act, 1860, there must be resolution passed by 2 /3 majority for amendment, correction or add rule.

9. **Dissolution: -** According to Para 13, 14 of Society registration Act, 1860, the Secretary body of Educational Society dissolved by 2 /3 majority.

10. **Situation after dissolution:-**

- A. After dissolution of milind Educational Society Brahamapuri and Secretary body. The resolution passed 2/3<sup>rd</sup> majority about assets of Society and this rule must be effected if Secretary body of Society failed to run the Educational Society.
- B. Every member shall be responsible for debt of Society at the time of dissolution.
